Tuition Fee Schedule 2017/18

The tuition fees which will be charged by UCA for the 2017/18 academic year are shown on the following page. These should be read in conjunction with the notes below and the UCA Fee Regulations which can be found on our website.

Note 1

These fee rates are valid for the 2017/18 academic year only and are subject to increase in future academic years. The fees stated for subsequent years of study should not be used as a guide as to what the fee level for that year of study might be in future academic years, as course fee structures change. Where year-on-year on-course fees are adjusted for inflation, this adjustment will be at or below the RPI-X forecast rate as advised by the independent Office for Budget Responsibility (OBR) and the Office for Fair Access (OFFA).

All fees are correct at the current time, but are subject to amendment as a result of changes in Government policy on tuition fees, entitlement to fee reductions and tax or benefit rules. Students should check for the latest information before enrolment

Note 2

For overseas students first registering in or after 2015/16: Overseas students progressing from a Further Education course (including International Foundation in Art & Design (IFAD)) to an Undergraduate course, from an Undergraduate course (including GDAD) to a Taught Postgraduate course, and from a Taught Postgraduate course to a Postgraduate Research course will be eligible for a 10% discount on the standard listed tuition fee for the first academic year of the course on to which they are progressing. If the student pays the discounted progression fee in full prior to enrolment then they will also be entitled to a 4% discount on the discounted progression fee. See individual course Fee Regulations for details.

For overseas students first registering prior to 2015/16: With the exception of students first registering on the Graduate Diploma in Art and Design (GDAD) or a stand alone pre-sessional English course, overseas students will pay, for the duration of uninterrupted studies (refer to the Fees Regulations for a full explanation of 'uninterrupted studies'), the fee rate in force in the year of first **registration – these historical fee rates can be accessed on the University website. Therefore the Overseas fee rates stated below** apply to new entrants only. The fixed fee does not apply to students progressing to the MBA. Overseas fee paying students progressing directly from the GDAD course at UCA to a UCA masters degree course will be entitled to a tuition fee discount of £1,000 in respect of the first year of that masters course. This will be subtracted from the standard listed fee at the time of enrolment. To be eligible for this discount students must enrol on the masters course in the academic year immediately following completion of their international pathway course. There is no discount for students progressing from a stand-alone pre-sessional English course.

Note 3

No part-time overseas fee rates are quoted as overseas students may normally only obtain a student visa for full-time study. Where exceptionally an overseas student is permitted to study in part-time mode an appropriate fee will be determined by the Deputy Registrar & Head of Student Administration, based on the pro rata full-time fee rate.

Note 4

For courses which include a pre-sessional English component an additional tuition fee will be charged, as follows: £1,780 for the five-week course and £3,560 for the 10-week course.

All amounts quoted are in pounds sterling (£).

*Undergraduate students from the Channel Islands and Isle of Man first enrolling in or after 2012/13 will be liable to the same fee as Home/EU students.

Home/EU fees for all years of study are expected to be as listed above but may change as a result of government policy.

NB: The stated full-time BA (Hons) fee applies to all new entrants to Higher Education in or after 2012/13 who are not eligible for the 'old regulations' funding regime that was in place prior to 2012/13. This may include direct entrants to other years. Conversely, students who are eligible for the 'old regulations' pre-2012/13 funding regime, including those repeating a year, in 2014/15 will be liable for the 'old regulations' fee. Eligibility is determined by Government. The 'old regulations' fees for full-time Home/EU students are determined annually by Parliament and are known as the 'regulated fees'.

PART TIME

The UCA Common Credit Framework permits Part-Time students to choose their intensity of study, provided that the total credit value of units taken each year is between 25% and 50% of the standard annual credit value of the Full-Time course. Fees are therefore calculated on a 'per credit' basis and are quoted per 10 credits. The fees listed below show the charge for a 10 credit unit. Fees for units of other sizes will be charged pro rata:

^c The stated Year 2 MArch fee for 2016/17 applies pro rata to continuing part-time students.

^d This fee applies to those students entering Higher Education in or after 2012/13 and who are not subject to the funding regime in place prior to 2012/13. This may include direct entrants to years other than Year 1. Eligibility will be determined by Government. See footnote b above.

Retakes

Students required to retake units with attendance will be charged per credit taken, in accordance with the Part-Time fee rates. For overseas students, there shall be no 'discounted' fee rate for retakes if paid in full prior to enrolment.
